- 6. elect vice presidential candidate
- 7. win support of general population through campaigns
- 8. population votes for favoured candidate
- 9. some weird state stuff happens (each state has a specific number of votes, which party a state votes for is determined by the majority of votes in that very state¹, a state sends delegates to Washington to vote as a proxy of the state)
- 10. the candidate with more than half of the total votes wins
